Online payment service to place funds in a detainee's commissary account.
Call to find out how to send a postal money order to an immigrant.

- go to <https://forecommsolutions.com/>
- click on **inmate deposit funds**
- select state: Louisiana
- click next
- facility: Allen Parish comes up, click next
- enter inmate A# or NAME then click next (name has to be spelt like it is at the facility)
- proceed with the instructions
- It will provide the prison ID # and birthdate..
- This is run by the sheriff's department.
- We do not know fees involved but there are fees.

[LASALLE CORRECTIONS FACILITIES](#) Jackson, Richwood, River, or Winn Correctional centers all use this process. *You Can only put money in 2 persons accounts per week.*

- **Online payment** <https://www.csppay.com/> to make a payment to immigrant by name and A#. Fees per deposit applies, Do NOT use your credit card, a cash advance fee will be charged by your credit card company. Use a debit card from your bank.
 - **For phone or inmate account assistance, please call 1-877-618-3516 you can set-up automated deposit.**

- **CASH - Make a cash payment on account when you are visiting, you must have detainee name and A#.**

GEOGROUP FACILITIES

- ***can only put money in 3 person's accounts per day.***
- ***Be aware that sometimes ICE spells person's name wrong so you may need the A# DO not to call the (866)345-1884 help line number. They charge a 1.50 fee.***
- ***USE A DEBIT CARD or draft from a bank, not a credit card (credit cards are charged as cash advance which incurs a fee from your credit card usually \$10 per charge).***

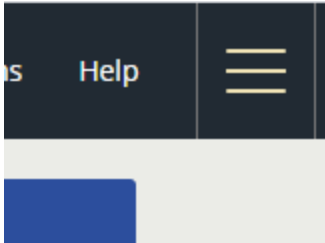

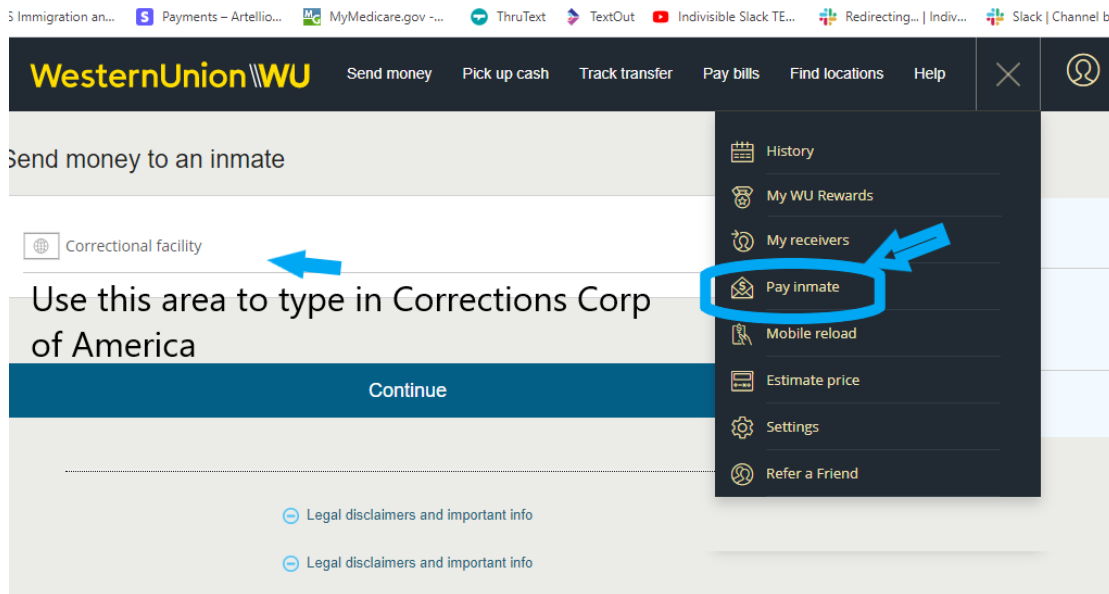
Steps to putting money in a commissary acct.

1. **YOU MUST HAVE THE IMMIGRANTS COMMISSARY NUMBER (this is not their A#)**
2. **Be aware there is a 7.95 fee per payment that will be added on to the amount.**
3. **Go to the western union website (linked above) and login or make an account if need be.**
4. **Use the drop down by clicking on the three lines next to help**



5. **Select PAY INMATE and then start to type Corrections Corp of America in the corrections facility area.**

Go to Western Union and make an account. Next enter your acct and us the drop down that is to the left of your name and select PAY INMATE
